Electronics Watch is seeking a part-time Development Consultant to support the Executive Director and other staff to prepare funding applications. The successful candidate will have demonstrated success in securing funds for not-for-profit organisations from diverse sources. They will have a keen understanding of the funding landscape in the field of international human rights and labour rights. This consultancy is limited to three months.

We coordinate worker-driven monitoring and remediation in collaboration with civil society organisations and trade unions in production countries, with a focus on the electronics and battery supply chains.

ABOUT THE ROLE

The Development Consultant will work with the Executive Director and other staff members to identify funding opportunities and prepare pitches and applications consistent with our strategic plan. While the core support for Electronics Watch are fees from its affiliates (public buyers), the Development Consultant will identify additional potential sources of income and how they will be secured.

RESPONSIBILITIES

The Development Consultant will work within the parameters provided and in coordination with staff members to:

- Prepare grant applications and other pitches to donors and clients. This includes standardizing language, as needed, that can be adapted in other contexts.
- Create and maintain a database of funding opportunities. This should include grants from both public and private sources, and opportunities for bespoke services to public authorities.
- Provide input on a forthcoming 36-month fundraising roadmap.

KEY COMPETENCIES

For this Consultancy position the following skills and experience are essential:

- 5–10 years of experience in fundraising for not-for-profit organisations.
- Demonstrated success in securing funds from multiple public and private sources
- Familiarity with the funding landscape in the field of international human rights and labour rights.
- Excellent writing skills for funding pitches and grant applications.
- High attention to detail and accuracy.
- Familiarity with the field of socially responsible public procurement.

DESIRABLE

- Understanding of social and environmental issues in mineral and manufacturing supply chains of electronics and batteries.
- Demonstrated capacity to design fundraising strategies and identify and manage potential donors over time.
- Familiarity working in small, flat and/or matrix type organisation.
- Experience working in organisations focused on international human rights and/or labour rights.
- Competence in additional languages such as French, Spanish, or German.
